

We support the application and suggest that some trees be planted in the Bush Reserve to aid rejuvenation and complete the bush setting. At present undergrowth is by general spraying which kills everything including any rejuvenation. Also request that a large open space be left in the park for the playing of games. A park bench or 2 would give a seat for adults to watch children, or just a sport to sit, rest or contemplate. There is a high portion of elderly who would enjoy a bench.

The reasons for making my/our submission are *(Attach any additional sheets used)*

The damage being caused to public and private property is on-going and getting worse as the trees get bigger. Health and Safety – there have been 2 cases of broken bones and several falls – 3 recently. There are many trip hazards causing issues for the users of the street. Jane Mander Retirement Village is at the end of the street and many residents walk this way (some with walking aids) but the uneven footpath is dangerous for them. Children on bikes and scooters, parents with pushchairs and young children toddling along – all have to navigate the rough uneven footpath. Trips are very common. Water pipes are being crushed and moved by the roots – in some cases storm water has to travel up-hill. We have a pool on the other side of our fence and are very concerned the tree roots will make their way to this.
