The reason(s) for my / our views / submission are:	I support the removal of the trees as sadly they are the cause of the damaged and dangerous footpath. These trees should be replaced with suitable preferably evergreen trees, that do not spread their roots widely. Not Ginkos.  The footpaths then need to be fully repaired. I understand the permanent repairs of the footpaths will have to be done as per the schedule of this programme.  ALL of this work and the expense should be met by Whangarei District Council. It is clearly a council responsibility.  I understand the residents of Brentwood Avenue support the removal of the trees, but there has been some suggestions of their contribution to cost and to cut costs they have discussed contributing to the labour involved which is ridiculous. Not only is it WDCs responsibility as this is public land and public trees, but the majority of the residents are senior citizens with limited physical and financial abilities. The removal of the trees will have both strict health and safety and road management requirements. None of this can be carried out or managed by residents.  In summary I fully support the need to remove these trees, but in no way should any of the residents be financially responsible for any of the costs incurred. This includes the cost of replacement trees.
