## Request to Operate a Remotely Piloted Aircraft (Drone) Over Land Owned by Whangarei District Council

Part 101 of the Civil Aviation Authority (CAA) Rule requires that operators of 'Remotely Piloted Aircraft Systems (RPAS) must obtain the consent of the property owner if they wish to fly their craft over land or property.

This form is for operators seeking to operate a RPA over Whangarei District Council property<sup>1</sup> (including parks, playgrounds, sports grounds, reserves, roads and other Council properties).

The term 'RPA' is used within this document to over Remotely Piloted Aircraft (including drone and model aircraft) which are also referred to as Unmanned Aerial Vehicle (UAVs) and Unmanned Aerial Systems (UAS).

The CAA rule requires that:

- An operator must not use airspace above people unless they have the consent of people below the flight; and
- An operator must not use airspace above an area of property unless prior consent has been obtained from any persons occupying that property or the property owner.

### Request under Section 30.2(i) of the Public Places Bylaw

This form also constitutes a request under Section 30.2(i) of the Public Places Bylaw which stipulates that no person shall land any aircraft, except in an emergency on any park or reserve, without the consent of the Chief Executive Officer or delegate.

# It is important that RPA / Drone operators familiarise themselves with the CAA rules and requirements.

You need to be 16 years or over to apply for consent, but you may apply for consent on the basis you will be supervising someone under 16 operating a Drone, UAV or RPAS.

Please note that further information may be required to enable Council to process your application.

An application for consent may be granted or refused by Council and may be subject to any conditions that the Council deem necessary to ensure safety to public, property and wildlife and the prevention of nuisance.

Please consider registering with the Air Share Website. This information helps CAA keep track of regular and non-regular UAV operators in each area.

### Code of Conduct

Any approval to operate a RPA over Council land is subject to the Code of Conduct. This requires the operator's agreement to not undertake any of the following activities:

- Operate a RPA over a sports field if it is in use;
- Operate a RPA over a playground, parked vehicles or roads;
- Operate a RPA within 20 metres of or over other users of the public space, unless you hold their prior consent;
- Operate a RPA within 50 metres of livestock, sensitive wildlife habitats such as wetlands, or nesting or roosting birds;
- Operate a RPA within 20 metres of or fly over park buildings and overhead wires
- Operate a RPA over dry flammable vegetation.
- Operate a RPA over adjoining private properties (unless you hold the prior written agreement of the property owner).
- Operate a RPA in a Council cemetery.

### The Operator of any RPA shall agree to:

- Be courteous of other members of the public.
- Keep the craft in full view at all times (e.g. not operated through binoculars, video monitor or smartphones, unless an observer is present)
- Fly in daylight hours only;
- Cease operation if requested by Council staff (or Council contractor).
